SUBJECT: Administrative Committee Meeting and Area Grower Meeting Schedule

The Far West Spearmint Oil Administrative Committee will meet on Wednesday, October 16, 2019 at the Red Lion Hotel, 304 SE Nye Ave, Pendleton, OR. The meeting will begin at 9:00 am with the main agenda item being the setting of the 2020-21 salable percentages. We have two room blocks available this year, one at the Red Lion in Pendleton and one at the Wildhorse Resort and Casino.

To make your reservation at the Red Lion call the hotel at 541-276-6111 and ask for the Far West Spearmint group rate of \$85.00. To receive the FWS group rate, reservations must be made by September 24, 2019.

To make your reservation at the Wildhorse Resort and Casino call the hotel at 1-800-654-9453 and ask for the Far West Spearmint group rate (Booking ID 14716) of \$107.96. To receive the FWS group rate, reservations must be made by October 1, 2019.

We will again hold area grower meetings prior to the main meeting. These are important meetings in that they give every grower, big or small, the opportunity to voice their input concerning the salable percentages to their Committee representative. A schedule of the area grower meetings and a listing of the current Committee is enclosed. Nominations for Committee Members and Alternates will be held in several areas. If you are interested in serving on the committee please let me or your Committee representative know.

We strongly encourage anyone interested in participating on the Committee to come to the meetings and seek to be nominated. USDA has asked that, where possible, we expand the nominees to include "women, minorities, those who are physically disabled, those who have not previously served as a member or alternate on the Committee, those representing organic or non-conventional farming, and those who represent farms defined as small businesses".

We will be holding the Annual Far West Spearmint Golf Tourney and BBQ on Tuesday, Oct. 15 at the Wild Horse Golf Course in Pendleton, OR. Enclosed is a flyer outlining the details of the event. Please note that we need to have a count of participants by October 11 in order to secure tee times. We hope to see many of you there.
